- The Company is exclusively in the Organic Chemical Segment.
- 3) The operations of Phthalic Anhydride Plant at Raichur, Karnataka was closed since July 2013. The Workmen's union of the unit have raised certain additional demands and the matter has been referred to Industrial Tribunal. Hubbali, Karnataka by the Labour Department, Government of Karnataka which is pending. Further the Company has filed a writ petition before the Hon'ble High Court, Karnataka. As the matter is subjudice, no provision has been made in this regard.
